a) EPSY 5304: Foundations and Content of School Counseling (CAR 22-12785)

Justification: The title was changed unofficially a few years and we want to make sure it is changed in the graduate catalogue. The course description and objectives will remain the same.

5304. School Counseling Program Development and Evaluation

3.00 credits

EDLR 1161: Introducing Food and Nutrition to Children through Reading (CAR 22-13625)

Justification: The current time commitment and work related to this course appear more than what should be required for a 1 credit course. The course requires 2 hours of site work per week as well as coursework. To align the course with the related hours and work, a 2 credit course is proposed.

Current Catalog Copy:

1161. Husky Reads: Introducing Food and Nutrition to Children through Reading. 2) New Courses

a) EPSY 3040: Learning Community Peer Mentoring, the Floor Mentor Experience (CAR 22-13245)

Explanation: Currently, EPSY 3020 (Peer Counseling) is a multi-section course which has a section for FYE Mentors and a section for Learning Community Floor Mentors. Different content is taught in each section, and over the past two years we have had students who want to participate in different mentoring programs in their time at UConn. Since EPSY 3020 is not repeatable for credit, it has been challenging to give students their well-deserved credits. In order to best serve students, we propose a new course (EPSY 3040) for Floor Mentors. Then each mentoring group will have their own course: EPSY 3020 (FYE Mentoring), EPSY 3030 (UConn Connects Mentoring), and EPSY 3040 (Floor Mentoring).

Course Description and Proposed Catalog Copy:

Learning Community Peer Mentoring, the Floor Mentor Experience

This course is designed to support peer mentors as they develop a more comprehensive understanding of the practical knowledge and skills needed for their LC Floor Mentor Role at the University of Connecticut (UConn). The learning experience will provide an understanding of student and community development, leadership, communication, and diversity. Through exposure to theories, experiential learning situations and the use of critical thinking and reflective analysis, participants will develop background and knowledge that will allow them to be successful in collaborating to build a cohesive community and supporting first-year LC students in their transition to UConn.

EDLR 6470: Racial Justice and Decoloniality in Higher Education Teaching (CAR 21-10068)

Course Description and Proposed Catalog Copy:

EDLR 6470: Racial Justice and Decoloniality in Higher Education Teaching: Theory and practice of how teaching within a higher education context can work toward racially equitable learning experiences and decoloniality of the classroom.

In this course, we will draw on teaching theories and practices to understand how college/university teaching can be enacted in ways that support racial equity in students' learning experiences and outcomes. In particular, we will focus on what it means to center racially minoritized students in the college classroom. We will also draw on teaching theories and practices to understand what it means to take a "decolonial turn" in teaching and learning experiences in college classrooms. In addition, we will engage in learning about similarities and differences between racial equity and decoloniality in teaching and learning within a higher education context.

 - a) EPSY: Counselor Education and Counseling Psychology (GPAR 22-PRES-EU4XCZ)

Current Name: Counselor Education and Counseling Psychology

Proposed Name: Counselor Education

Justification: The only change is deleting the term "counseling psychology" from the graduate catalog Counselor Education and Counseling Psychology M.A. and Ph.D.

The coursework in our program is aligned with and accredited by The Council for Accreditation of Counseling and Related Educational Programs (CACREP) and no longer includes counseling psychology. The school program, future doctoral program, and any other certificates or programs will be aligned with CACREP standards. Additionally, as part of our accreditation, we must make it clear that our identity, as a program, is counselor education.
